Course Objectives

The course is designed to explore the interactions between China and the United States since the first Opium War. Beginning with a brief evaluation of Sino-US relations since the First Opium War, the course will examine how the two nations had interacted with each other at some historical junctures with a focus on the bilateral relations in the past one hundred seventy years. The course will examine some important events during different historical periods and uncover their underlying causes.

With knowledge of the historical interactions, the course will look into some the grand strategic rivalry between China and the United States caused by China's rise and the US' reactions.

Course Requirements

- (1) Each student is strongly encouraged to participate in class discussions and make a vigorous presentation; the presentation topics will be assigned by your instructor in advance;
- (2) Each student is also required to write two short essays on the topics assigned by your instructor; the essay should be typed in double space, use a 12-point font (preferably Times or Times Roman), and 3-5 pages in length. The main sources of citation must be academic journals, books and serious newspapers. Plagiarism is strictly prohibited. Late submission, poor grammar or spelling and improper citation style will be counted against your grade.
