Description

This course examines the history of racial thinking and the experience of racialization in Latin America. Using Colombia as a case study, the course explores the changing dynamics of racial categories, particularly blackness, from the end of the colonial period to the present. Employing an intersectional approach, the course pays particular attention to how discourses of race, gender, class, war and geography intersect to create identities that are complex and multifaceted yet circumscribed by the socio-historical context in which they flourish.

Objectives

Through their participation in this course, students will:

- Be able to discuss the different histories of racial formation in Latin America
- Identify the major political, economic and social trends in Colombia
- Develop a basic understanding of the theories and research methods used in the study of race and identity in different fields and disciplines
- Gain a solid grasp of the intersection of race, class, gender, violence, and geography in the shaping of identity in Colombia
- Sharpen critical thinking and intercultural communication skills

Course Requirements

The course consists of class lectures, open discussions, and field visits to organizations, communities, and government offices. Students are expected to actively participate in all lectures and out-of-classroom activities. Reading assignments are generally 30-40 pages per class session.

Each student will be required to give an oral presentation about one aspect of race and identity, write 3 analytical essays (3-5 pages each), and one field report.

Students are expected to attend each class and field-based course component, as outlined in the CET Attendance Policy.
