Description

This course explores the organizational, social and political processes though which Afro-Colombians have fought to be recognized as a distinctive ethnic group and to eliminate racial discrimination. Despite the historical and structural racism that has disregarded Afro-Colombians as political actors, they have developed organizational processes that enabled autonomous living in their ancestral territories, political participation in the national arena, and resisting the violence of the internal armed conflict that has targeted them over the past two decades.

Emphasis is made on critical political and institutional processes: the 1990 Colombian constitutional reform that led to the recognition of the multicultural character of the nation and to the granting of collective land titles to Afro-Colombian communities, the establishment of a public policy system towards Afro-Colombians with ambivalent results, the Afro-Colombian organizational responses to address the rampant human rights violations against their communities that led to new mechanisms of articulation with transnational black and human rights activism, and their current political mobilization to be adequately included into the peace building process. The course offers an opportunity to understand a unique historical experience among Afro-Descendants globally: a struggle for racial justice that pursues equality and inclusion but also the right to be different.

Objectives

In this course, students

 Learn the basic concepts and information required to understand the emergence, evolution, trajectories and diversity of Afro-Colombian collective action.

- Identify the most relevant contextual factors, both domestic and international, that have influenced the configuration and transformation of Afro-Colombian social movements.
- Examine how Afro-Colombians have faced several historical adversities and challenges though their persistence in reclaiming the right of equality and the right to be different.
- Become familiar with the most relevant experiences carried out by Afro-Colombian organizations that have pursued diverse agendas within the common horizon of claiming racial justice.

Course Requirements

Students are expected to be very active in the discussions of each session. Therefore, they must read assigned readings (20-30 pages per week). For most of the sessions, students must write a short paragraph offering a reflection/comment based on the reading. This assignment is part of the participation grade. Students also should prepare an oral presentation about one of the assigned readings. In terms of written assignments, students have to elaborate two 5-page analytical papers and one 10-page final paper.

Students are expected to attend each class and field-based course component, as outlined in the CET Attendance Policy.
